

**Notice regarding the Status of Share Repurchase
(Share Repurchase under Article 165 (2) of the Companies Act)**

May 2, 2023 – At the Board of Directors held on March 9, 2023, Sekisui House, Ltd. resolved on matters relating to its share repurchase under Article 156 of the Companies Act, as applied pursuant to Article 165 (3) of the Companies Act. The status of the share repurchase is as follows.
